PERFORMANCE WORK STATEMENT

A.1. GENERAL

A.1.1. The Contractor shall provide Red River Army Depot (RRAD) with sufficient personnel, equipment, tools, transportation, tracking documents (manifest) and any other items necessary to perform services related to the marking/labeling, loading, transporting, removal and disposal of waste for RRAD. The contract shall be a requirement contract for a base year and two (2) options years. RRAD is located 18 miles west of Texarkana, Texas, in the northeast corner of Texas. The industrial activities at RRAD generate significant quantities of hazardous and non-hazardous waste associated with metal cleaning, painting, de-painting, and electroplating. Waste generated at RRAD is State and Federal regulated and listed on a Notice of Registration (NOR) with the State of Texas Regulatory Agency.

A.1.2. The contract consist of three (3) different type of waste removals:

(1) Removal of containerized (drum) universal waste paint & paint related material, i.e., mixed paint & solvent blend

(2) Removal of containerized (drum) universal waste paint & paint related material, i.e., liquid or dried paint with cans

(3) Removal of containerized (drum) universal waste paint related material, i.e., paint rags

A.1.a. The contract is managed by the Universal Waste regulations under the State of Texas regulations, 30 Texas Administrative Code (TAC) 335.262 and related chapters to an approved Treatment, Storage and Disposal Facility (TSDF) in Texas, in accordance with all applicable Federal and State regulations/laws. In the State of Texas, "Paint and Paint Related Materials" may be classified and managed as Universal Waste.

A.1.b. The Paint and Paint Related materials under this contract may include mixed paint waste which is a mixture and blend of various types of paints and solvents, off specification and/or unused paints and solvents that are no longer needed and/or have dried in its container, and paint rags which are generated from the clean up or wiping of paints and/or

solvents. (See Schedule for Line Item details). The characteristics of the waste that may be offered to the Contractor will be classified as a Hazardous Waste, with EPA codes that may include D-Listed such as D001, D006, D007, D008 and D035 and F-Listed such as F003 and F005 that will be managed as Universal Waste.

A.1.c. All waste material will be in 55-gallon containers furnished by the Government. Contractor shall be responsible for providing all applicable documentation for transportation and tracking of the waste such as a Uniform Hazardous Waste Manifest (UHWM) and Land Disposal Restriction (LDR) forms. Contractor personnel performing any portion of this contract shall be in compliance with all applicable training requirements identified by EPA, OSHA, DOT and State regulations, with certification provided to designated Government personnel prior to any work start up.

A.2. REGULATORY COMPLIANCE:

A.2.1. The contractor shall ensure that all contractor personnel and employees performing any part of this contract are familiar with and maintain compliance with all Federal, State and Local Regulations/Laws governing health, safety and environmental protection during the duration of this contract. Certification of compliance will be provided at contractor expense for all personnel performing any portion of this contract.

A.2.2. Contractor will be responsible for providing a listing of EPA/State licensed Transporter companies that will be used and the name of all Treatment, Storage and Disposal (TSD) facilities located in the State of Texas that will be receiving RRAD waste for treatment and disposal. These facilities must be in compliance with all Federal and State regulations governing waste transporting, treatment and disposal. The Government reserves the right to disapprove the use of any transporter and/or TSD facility on list provided by contractor at anytime if there deems reasons that a non-compliance situation may arise or has arose.

A.2.3. Contractor is responsible for providing all Department of Transportation (DOT) labels and ensuring all labels are affixed and properly filled out prior to shipment on public highways. Placards and Labels for transport vehicle are also the responsibility of the transportation company utilized.

A.2.4. Contractor is responsible for preparing all manifest and providing these documents to Government designated representative prior to shipment of waste off-site (RRAD).

A.2.5. Contractor is responsible for ensuring all containers of waste shipped off-site (RRAD) reaches designated/approved TSD facility and original manifest receipt copy is returned to RRAD Government designated representative within 30 days from time of shipment.

A.2.6. Contractor will be provided with a waste classification profile, classifying all waste that will be offered to the contractor. It is the contractor's responsibility to properly profile waste into approved TSD facilities covering all waste under this contract. Contractor

shall provide Government designated representative copies of all profiles used for classifying waste into the TSD Facilities.

A.2.7. Contractor has the responsibility to ensure all workers are provided safety equipment and Personnel Protective Equipment (PPE) when required while at RRAD. Contract employees must be properly trained in the use of PPE that is provided.

A.3. PROJECT MANAGER

A.3.1. Contractor shall provide a designated representative and/or Project Manager who shall be responsible for the performance of the work under this contract. The name and phone number of this person shall be designated in writing to the Contracting Officer, Red River Army Depot. The designated representative shall be available in person or by telephone during duty hours to discuss any problem areas, oversight of all work performance and interaction with designated Government personnel. The Project manager must have full authority to act for the contractor on all matters pertaining to the performance of this contract.

A.4. SECURITY REQUIREMENTS

A.4.1. Contractor personnel or any representative of the contractor entering Red River Army Depot or any of its interiorly secured areas shall abide by all security procedures and shall be subject to security searches or inspections at anytime.

A.4.2. Security Plan requirements in accordance with 49 Code of Federal Regulations (CFR) 172 shall be followed by the Contractor. For the purpose of this contract, Contractors Security Plan must include requirements for shipments requiring placards and a copy shall be provided to RRAD prior to any work being performed under this contract, and/or Contractor shall provide a written certification that a Security Plan is in place and it meets all the requirements of 49 CFR 172.

A.5. VEHICLES REGISTRATION AND IDENTIFICATON

A.5.1. Contractor owned and operated vehicles entering Red River Army Depot shall have a valid and current State Drivers License and vehicle registration during the time the vehicle is in use on the installation.

A.6. WORK SCHEDULE & WORK HOURS

A.6.1. Normal business work hours at Red River Army Depot will be between Monday through Thursday, 6:30 a.m. to 5:00 p.m. Central Standard Time. All work scheduled will be performed during normal business hours.

A.6.2. Red River Army Depot observes Legal Holidays as follows:

When any of the above legal holidays falls on a Sunday, the following Monday will be observed as a legal holiday. When a legal holiday falls on a Friday or Saturday, the preceding Thursday is observed as a holiday by the U.S. Government.

A.6.3 Contractor has total responsibility to ensure all work is scheduled in accordance with normal business work hours and outside any legal holidays observed by Red River Army Depot.

B.1. DELIVERY AND PERFORMANCE

B.1.1. Contract is for a one-year period from the effective date of the contract, with two (2) option years. Quantities are estimates only with no guarantee of minimum or maximum quantity per delivery. No funds will be obligated by the award of the contract, but will be obligated by issuance of delivery orders. Failure of the Government to furnish such items in the amounts or quantities described in this schedule as "estimated" or "maximum" will not entitle the contractor to any equitable adjustments in price.

B.1.2. It is the contractor's responsibility to report on-site with all necessary personnel, equipment, supplies, paperwork, transportation, etc., for work start-up within 48 hours after receipt of Delivery Order. Example: forth eight (48) hours will be counted as continuous hours, i.e., call made at 2:00 p.m. on Monday, contractor shall respond prior to 2:00 p.m. on Wednesday of that same week. Contractor will coordinate the service schedule with the Contracting Officer Representative (COR).

B.1.3. Contractor shall take full responsibility for liability associated with the transportation of roll-off containers to and from Red River Army Depot. Contractor will be responsible for any damages to government property. Contractor shall notify COR of any damage at the time of incident.

B.2. EMERGENCY SERVICE

B.2.1. Contractor shall respond within 24 hours after receipt of an emergency service request. Emergency service request will be made by the Contracting Officer's Representative (COR), Contracting Officer or Contract Administrator.

B.3. SPILL CLEANUP

B.3.1. In the event that a spill occurs which is generated by the contractor during the performance of service, the contractor shall provide all materials, labor and equipment necessary for the cleanup and protection of surrounding personnel, equipment and the environment at no cost to the Government.

B.4. INSPECTION AND ACCEPTANCE

B.4.1. Inspection and acceptance will be at the job site where work is being performed. A Contracting Officer Representative (COR) shall be responsible inspection and acceptance of the services to insure compliance with the terms of the contract. Inspection and acceptance will not be done until all work has been completed by contractor for specific order.

B.4.2 Contractor shall take full responsibility for liability associated with the performance of this work at Red River Army Depot. Contractor will be responsible for any damages to government owned equipment while on-site. Contractor shall inspect containers while on-site and shall notify COR of any damage found.

52.000-4002 CONTRACTOR MANPOWER REPORTING (Oct 2005)

(a) Scope. The following sets forth contractual requirements, and related policies and procedures, for reporting of contractor labor work year equivalents (also called Contractor Man-year Equivalents (CMEs)) in support of the Army, pursuant to 10 U.S.C. 129a, 10 U.S.C. 2461(g), and Section 343 of Public Law 106-65. Reporting shall be accomplished electronically by direct contractor submission to a secure Army Web Site:
<https://contractormanpower.army.pentagon.mil/>.

(b) Purpose. The purpose of this reporting requirement is to respond to Congressional requests; significantly improve reports to Congress and to internal Army manpower and force management planners and decisionmakers; and, to broadly quantify the extent of CMEs used to support Army operations and management under the Federal Supply Class and Service Codes for "Research and Development: and "Other Services and Construction." The Army's objective is to collect as much significant CME data as possible to allow accurate reporting to Congress and for Army planning purposes. The reporting data elements should not be viewed as an "all or nothing" requirement. Even partial reporting, e.g. direct labor hours, appropriation data, place of performance, Army customer, etc., will be helpful.

(c) Applicability. This reporting requirement applies only to services covered by Federal Supply Class or Service codes for "Research and Development," and "Other Services and Construction." If the contractor is uncertain of the coding of the services performed under this contract/order, or the scope and frequency of reporting, guidance may be obtained from the

Army Web Site Help Desk, other HQDA contacts cited at the Web Site, or from the contracting officer. Classified contract actions are not, per se, exempt from this requirement. Report submissions shall not contain classified information.

(d) Requirements. The contractor is required to report the following contractor manpower information, associated with performance of this contract action in support of Army requirements, to the Office, Assistant Secretary of the Army (Manpower and Reserve Affairs), using the secure Army data collection web-site at <https://contractormanpower.army.pentagon.mil/>:

(1) Direct Labor. Direct labor hours and the value of those hours;

(2) Indirect Labor. Composite indirect labor hours associated with the reported direct hours, and the value of those indirect labor hours plus compensation related costs for direct labor hours ordinarily included in the indirect pools; or two distinct, relevant annual composite or average indirect labor rates. If used in lieu of raw indirect labor hours and the value of those indirect hours, the rates may be annualized average estimates for the reporting contractor and need not be developed for each reporting period.

(i) Composite Indirect Rate for Indirect Manhours. If provided, the composite indirect labor rate will be used to grossly estimate the number of indirect hours associated with services reported in each period, when multiplied by the reported direct labor hours.

(ii) Composite Indirect Rate of Compensation Value. If provided, a different composite indirect labor rate will be used to grossly estimate the value of compensation related charges not included in the value of direct labor charges, when multiplied by the reported direct labor value. This rate shall include: salaries and wages for indirect labor hours; directors' fees; bonuses (including stock); incentive awards; employee stock options; stock appreciation rights; employee insurance, fringe benefits (e.g., vacation, sick leave, holidays, military leave, supplemental unemployment benefit plans); contributions to pension plans (defined benefit, defined contribution); other post-retirement benefits, annuity, and employee incentive compensation and deferred compensation plans; early retirement plans; off-site pay; incentive pay; hardship pay; severance pay/ and COLA differential;

(iii) Actual Estimated Indirect Labor Hours and Value(s). Contractors may choose to report estimated total hours and dollars for indirect labor (related to the reported direct labor) and compensation charges not reported as direct labor charges (as opposed to providing average composite rates.) Either method chosen should be consistently reported.

(e) Report Exemption(s). In the rare event the contractor is unable to comply with these reporting requirement without creating a whole new cost allocation system or system of record (such as a payroll accounting system), or due to similar insurmountable practical or economic reasons, the contractor may claim an exemption to at least a portion of the reporting requirement by certifying in writing to the contracting officer the clear underlying reason(s) for exemption from the specified report data elements, and further certifying that they do not otherwise have to provide the exempted information, in any form, to the United States Government. This certification is subject to audit and potential legal action under Title 18, United States Code. The contractor may not claim an exemption on the sole basis that they are a foreign contractor; that services are provided pursuant to a firm fixed price or time and materials contract or similar instrument; or on the basis that they have sub-contracted their payroll

system, or have too many subcontractors. If the contracting officer, by written notice, determines that the "self-exemption" is lacking in basis or credibility, the contractor shall comply with the subsequent direction of the contracting officer, whose decision is final in this matter.

(f) Uses and Safeguarding of Information. The information submitted will be treated as contractor proprietary information when associated with a contractor name or contract number. The Assistant Secretary of the Army (Manpower and Reserve Affairs) will oversee the aggregation of this information and will exclude contract number and contractor name from any use of this data (except as necessary for internal Army verification and validation measures). The planning factor(s) derived from this data by ASA (M&RA) and its contract support (if any) will be used solely for Army manpower purposes and will not be applied to any specific acquisition(s). Detailed data by contract number and name will not be released to any Governmental entity other than ASA (M&RA), except for purposes of assessing compliance with the reporting requirement itself, and will only be used for the stated purposes (reporting and planning). Any potentially sensitive data released within the Army or to its contractor will be clearly marked as contractor Proprietary. Non-sensitive roll-up information may eventually be published for public inspection after such data has been validated as deemed appropriate.

(g) Sub-Contractor(s). The contractor shall ensure that all reportable sub-contractor data is timely reported to the data collection web site (citing this contract/order number). At the discretion of the prime contractor, this reporting may be done directly by subcontractors to the data collection site; or by the prime contractor after consolidating and rationalizing all significant data from their sub-contractors.

(h) Report schedule. The contractor is required to report the required information to the Office of the Assistant Secretary of the Army (Manpower and Reserve Affairs) data collection web site generally contemporaneous with submission of a request for payment (for example, voucher, invoice, or request for progress payment), but not less frequently than quarterly, retroactive to October 1, 1999, or the start of the contract/order, whichever is later. Deviation from this schedule requires approval of the contracting officer.

(i) Reporting format. The information required should be reported electronically to the M&RA data collection point, at <https://contractormanpower.army.pentagon.mil/>. This web site identifies and explains all the mandatory data elements and format required to assure reliable and consistent collection of the data required by law, and includes, but is not limited to, identification of the information collected pursuant to Sec. 668.2(d)(1) and (2) as related:

(1) Reporting to congress or Army Leadership. Data elements required for reports to Congress and Army manpower planning, such as: the applicable federal supply class or service code, appropriated data (and estimated value for each appropriation where more than one appropriation funds a contract), major Army organizational element receiving or reviewing the work, and place of performance/theater of operation where contractor performs the work.

(2) Data Credibility. Data elements required for purposes of assuring credible and consistent reporting and general compliance with the reporting requirement, such as: beginning and ending dates for reporting period; contract number (including task or delivery order number); name and address of contracting office; name, address and point of contact for contractor; and total estimated value of contract.

(j) Reporting Flexibility. Contractors are encouraged to communicate with the help desk identified at the data collection web site to resolve reporting difficulties. For example, contractors may use the remarks field to identify multiple delivery orders associated with a single data submission or record, so long as the contract number, federal supply or service code, major Army organizational element receiving or reviewing the work, and contracting office are the same for the reporting period for that set of delivery orders, rather than entering a separate data submission or record for each individual delivery order. Subcontract data may also be consolidated in a single report for a report period. Other changes to facilitate reporting may be authorized by the contracting officer or the Help Desk (under Army policy direction and oversight).

The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights (1) within a reasonable time after the defect was discovered or should have been discovered; and (2) before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). (c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to the Contract Disputes Act of 1978, as amended (41 U.S.C. 601-613). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.--

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

52.233-3 PROTEST AFTER AWARD (AUG. 1996)

(a) Upon receipt of a notice of protest (as defined in FAR 33.101) or a determination that a protest is likely (see FAR 33.102(d)), the Contracting Officer may, by written order to the Contractor, direct the Contractor to stop performance of the work called for by this contract. The order shall be specifically identified as a stop-work order issued under this clause. Upon receipt of the order, the Contractor shall immediately comply with its terms and take all reasonable steps to minimize the incurrence of costs allocable to the work covered by the order during the period of work stoppage. Upon receipt of the final decision in the protest, the Contracting Officer shall either--

(1) Cancel the stop-work order; or

(2) Terminate the work covered by the order as provided in the Default, or the Termination for Convenience of the Government, clause of this contract.

(b) If a stop-work order issued under this clause is canceled either before or after a final decision in the protest, the Contractor shall resume work. The Contracting Officer shall make an equitable adjustment in the delivery schedule or contract price, or both, and the contract shall be modified, in writing, accordingly, if--

(1) The stop-work order results in an increase in the time required for, or in the Contractor's cost properly allocable to, the performance of any part of this contract; and

(2) The Contractor asserts its right to an adjustment within 30 days after the end of the period of work stoppage; provided, that if the Contracting Officer decides the facts justify the action, the Contracting Officer may receive and act upon a proposal at any time before final payment under this contract.

(c) If a stop-work order is not canceled and the work covered by the order is terminated for the convenience of the Government, the Contracting Officer shall allow reasonable costs resulting from the stop-work order in arriving at the termination settlement.

(d) If a stop-work order is not canceled and the work covered by the order is terminated for default, the Contracting Officer shall allow, by equitable adjustment or otherwise, reasonable costs resulting from the stop-work order.

(e) The Government's rights to terminate this contract at any time are not affected by action taken under this clause.

(vi) All personnel will adhere to all depot fire, safety, security, and other applicable regulations.

52.236-4032 SAFETY AND OCCUPATIONAL HEALTH REQUIREMENTS

(a) The contractor shall furnish all personnel and material necessary for the prevention of accidents, injury or damage to employees or equipment while operating on a Federal reservation. Also includes personnel and equipment necessary for the prevention of accidental damage to Government property, Federal employees or other U.S. Government contractor personnel.

The contractor shall furnish and erect adequate warning signs, flashing lights, and barricades to properly control traffic movements around or through the construction site. The contractor shall provide and maintain any detours or crossovers necessary for the safety and convenience of traffic.

(f) Contractor and Employee Vehicles. Contractor vehicles must meet with current state safety regulations and an appropriate sticker affixed in the lower left corner of the windshield. Vehicles not meeting the state safety codes will not be allowed on RRAD. Those which have a safety inspection expire while on RRAD will be removed and properly recertified NLT 15 days prior to the expiration date. Vehicles found to be out of inspection date will be ordered off of the depot and the contractor decal removed. Vehicles found by RRAD Safety personnel to be unsafe for RRAD operations will be brought to the attention of the contractor who will either repair the vehicle or remove it.

(g) Contractors are responsible for their employees' conduct and their vehicles. Employees with unsafe vehicles will be required to remove them from RRAD until they can be repaired.

(h) Accidents, other than minor first aid injuries, will be reported directly to the RRAD Safety Office at 2115 during duty hours. These are reportable on a Department of Army Form 285 when they occur on U.S. Federal property. The RRAD Safety Office will assist in the preparation of all accident reports at no cost to the contractor.

(i) The Contracting Officer will notify the contractor in writing of any observed non-compliance with the foregoing provisions. The contractor shall, after receipt of such notice, immediately take corrective action. The Safety Manager may make direct contact with a contractor or his authorized representative for conditions of imminent danger to life or U.S. Government property. In such cases, the Contracting Officer will be immediately notified. In cases which have the potential for embarrassment to the U.S. Government, or Red River Army Depot, the Contracting Officer will notify the contractor verbally to be followed up by a written report

of the situation and the action to be taken to correct it. If the contractor fails or refuses to promptly take corrective action, the Contracting Officer will issue an order stopping all or part of the work until satisfactory corrective action has been taken. No part of the time lost due to such stop orders will be made the subject of a claim for extension of time or for excess costs or damages by the contractor unless it was later determined that the contractor was in compliance.

52.236-4033 FIRE PREVENTION AND PROTECTION

The contractor shall comply with all fire prevention measures prescribed in the installation fire regulations, a copy of which is on file in the office of the Contracting Officer.
