

SCOPE OF WORKPART I
STATEMENT OF WORK

SW-1 DESCRIPTION OF WORK

- A. Work to be done: The works to be done consists of furnishing all plant facilities, labor, materials, and equipment and performing all work in strict accordance with these specifications to furnish and install two each (2) Horizontal Spindle Mobile Nutrunner Carts with DC Tooling torque tools for removing and installing lug nuts on the MRAP and FMTV Lines, located in bldg. 333 at Red River Army Depot, Texarkana, Texas.
- B. Location: The work site contemplated by these specifications is located approximately 18 miles west of Texarkana, Bowie County, Texas, on U.S. Highway 82. The main entrance to the depot is 0.3 mile south of Exit 206 on Interstate Highway 30.

SW-2 PRINCIPAL FEATURES: The work to be done includes the following principal features:

- A. The Contractor shall furnish all tools, materials, labor, equipment, installation, parts manuals, and training required to support production lines.
- B. Requirements DC Tooling
1. The Contractor shall provide two (2) each horizontal Spindle Mobile Wheel Nutrunner Carts adjustable centers to remove lug nuts and install lug nuts on the MRAP and FMTV. Each consisting of the following:
 - a. One (1) each Base Frame with 8-inch heavy duty polyurethane wheels for operation on workshop floor.
 - b. One (1) each Spindle base plate with spindle layout according to the application.
 - c. One (1) Rear Rotate handle.
 - d. Four (4) each Reaction bars.
 - e. One (1) manually operated hand crank for adjusting spindle centers with four (4) each Reaction bars to react off inside of wheel rim.
 - f. One (1) Rear Rotate Bearing assembly.
 - g. One (1) Crank Handle for manual height adjustment from floor to center of wheel: minimum 15-inches to maximum 36-inches.
 - h. One (1) Operator Panel with Start/Stop/Parameter Select Functions.
 - i. One (1) each Lot, Misc Hardware.
 - j. Two (2) each Electric fixture Inline nutrunner, torque range 150-700 ft lb, 2-inch axial float and 1-inch drive.
 - k. Two (2) each standard surface drive sockets, size 1 1/16-inch for the MRAP lugs, and Two (2) each standard surface drive sockets, size 1 1/2-inch for the FMTV lugs.
 - l. Standard controller mounting plate.
 - m. Bolt circle/bolt pattern: minimum 5-inch diameter to maximum 13-inch diameter equally spaced.
 - n. The lugs shall be torque to 450 ft lbs. Lugs are left hand and right hand threads.
 - o. One (1) each Power FOCUS Graph Controller and One (1) each Power Focus Compact Controller mounted in cart cabinet, with two (2) each RBU-X, with two (2) each 10 meter spindle tool cables, with one (1) each Accessory Cable, with one (1) each I/O expander and I/O bus cable.
 - p. One (1) on board Epson LXX 300 + II or equal impact Printer with mounting hardware
 - q. One (1) each Fastening Program.
 - r. Standard Documentation consisting of the following (English Only), Electrical Controls Drawings, Mechanical Drawings, and One (1) each CDROM with all Final Documentation in Electronic Format at containing the following: General information, installation instructions, tool information, preventative

maintenance information, mechanical documentation, controls documentation, spare parts information, and miscellaneous information.

- s. Install controllers, tools, and calibrate.
- t. Provide operational manuals, parts breakdown and list for controllers, tools, and how to calibrate
- u. Provide training.
- v. The contractor shall provide the RRAD of electrical requirements.

C. All electrical shall be install in accordance with National Electric Code.

D. The area shall be kept clean of all debris at all times and after work is completed.

SW-3 APPROVAL OF MATERIALS: Prior to ordering materials, the Contractor shall provide a list and picture or drawings of materials that will be used and all electrical and air requirements. Material submittals to the Contract Officer, who will then forward the submittals to COR for approval. The Government reserves the right to reject the spindle wheel if it does not perform as requested by user.

SW-4 SAFETY REQUIREMENTS: All OSHA Rules and Regulations apply to this project as well as local safety regulations.

SW-5 ENVIROMENTAL: All Environmental regulations shall apply to this project.

SW-6 ON SITE VISIT: The Contractor is encouraged prior to submission of bid, to visit Red River Army Depot, and visit with the user to provide the best product, located bldg. 333 during normal hours to satisfy him/her self as to the scope of work to be accomplished. The Contractor's failure to comply with this provision shall in no way relieve him of performing the work required under this contract. It is requested that the Contractor verbally advise the Contracting Officer at least twenty-four (24) hours in advance of his planned visit.

SW-7 SPECIAL REQUIREMENTS:

A. Utility outages shall be minimized.

- 1. All utility outages shall be approved by the Contracting Officer's Representative in writing prior to disruption of utilities.
- 2. Contractor shall submit a posed schedule of outages showing as a minimum: dates of outages, duration of outages and type of outages required.
- 3. All utility outages required by the Contractor to accomplish his work shall be scheduled a minimum of 14 calendar days in advance.

B. Time requirements for completion:

- 1. **Start Work:** The Contractor shall start work 7 calendar days after he/she receives notification to start work.
- 2. **Completion of Work:** The Contractor shall complete work within 120 calendar days after he/she receives notification to start work.
- 3. Contractor shall notify Government 7 days in advance of construction requiring movement of material from adjacent areas.

C. Normal hours of work will be from 6:30 AM until 5:00 PM, Monday thru Thursday (excluding holidays), unless Contract Officer specifically approves other hours.

TECHNICAL PROVISIONS
SECTION 2A
SPECIAL PROVISIONS

1. GENERAL: This section covers special contract requirements, not specifically defined elsewhere on the contract drawings or other sections of these specifications, which are manifestly necessary to carry out the intent of the drawings and specifications
2. COORDINATION OF WORK
 - 2.1 The Contractor shall execute work so as to interfere as little as possible with normal functioning of existing buildings or operation, including operations of utility services, fire protection systems and building equipment.
 - 2.2 Safety and Occupational Health requirements are included in the 'Special Contract Requirements' provided elsewhere in the contract document. Contractor shall become familiar with and shall demonstrate full compliance with all safety requirements specified in OSHA Parts 1910 and 1926, U. S. Army Engineer Manual 385-1-1, Army Regulations and Red River Regulations.
 - 2.3 Buildings occupied during performance of work: Contractor shall take all measures and provide all material necessary for protecting existing equipment, property, and ongoing operations in affected areas of construction against dust and debris.
3. APPROVAL OF MATERIALS AND EQUIPMENT: Before starting installation of any material, the Contractor shall submit to the Contracting Officer for approval, in quadruplicate, complete lists of materials and equipment to be incorporated in the work. The lists of materials and equipment shall be supported by sufficient descriptive material, such as catalogs, cuts, diagrams, and other data published by the manufacturer, to demonstrate conformance to the specification requirements; catalog numbers alone will not be acceptable.
4. UTILITIES:
 - 4.1 The Government will provide the Contractor, from existing outlets and supplies, all reasonably required amounts of utilities, as determined by the Contracting Officer. The Contractor shall carefully conserve utilities furnished without charge. The Contractor, at his own expense and in a workmanship manner satisfactory to the Contracting Officer, shall install and maintain all necessary temporary connections and distribution lines and shall remove the same prior to final acceptance of the construction.
5. HOURS OF WORK:
 - 5.1 Normal hours of work during the contract period shall be identical to the hours worked by the Contracting Officer or COR, unless the Contracting Officer specifically approves other hours. However, if the Contracting Officer/COR'S work schedule is altered during the contract period, the Contractor shall adjust his work schedule accordingly.
6. WARRANTY OF CONSTRUCTION:
 - 6.1 General: In addition to any other warranties set out elsewhere in this contract, the Contractor warrants that work performed under this contract conforms to the contract requirements and is free of any defect of equipment, material or design furnished, or workmanship performed by the Contractor or any of his subcontractors or suppliers at any tier. The warranty shall continue for one year from the date of final acceptance of the project. Under this warranty, the Contractor shall remedy at his own expense any such failure to conform or any such defect. In addition, the Contractor shall remedy at his own expense any damage to Government owned or controlled real or personal property, when that damage is the result of the

Contractor’s failure to conform to contract requirements or any such defect of equipment, material, workmanship, or the terms of this clause. The Contractor’s warranty with respect to work repaired or replaced hereunder will run for one year from the date of such repair or replacement.

6.2 Notification and Compliance: Within a reasonable time the Government shall notify the Contractor in writing after the discovery of any failure, defect, or damage. The failure of the Contractor to remedy any defect, or damage described in these specifications within a reasonable time after receipt of notice, the Government shall have the right to replace, repair, or otherwise remedy such failure, defect, or damage at the Contractor’s expense.

6.3 Expressed Warranty: In addition to the other rights and remedies provided by this clause, all subcontractors’, manufacturers’ and suppliers’ warranties expressed or implied, respecting any work and materials shall, at the direction of the Government, be enforced by the Contractor for the benefit of the Government. The Contractor shall obtain any warranties that the subcontractors, manufacturers, or suppliers would give in normal commercial practice. If so directed by the Contracting Office, the Contractor shall require any such warranties to be executed in writing to the Government.

6.4 Latent Defects: The warranty specified herein shall not limit the Government’s rights under the Inspection and Acceptance clause of this contract with respect to latent defects, gross mistake, or fraud.

For items that are serialized within the part, lot, or batch number within the enterprise identifier, the unique item identifier shall include the data elements of the enterprise identifier; the original part, lot, or batch number; and the serial number.

Enterprise means the entity (e.g., a manufacturer or vendor) responsible for assigning unique item identifiers to items.

Enterprise identifier means a code that is uniquely assigned to an enterprise by an issuing agency.

Government's unit acquisition cost means--

(1) For fixed-price type line, subline, or exhibit line items, the unit price identified in the contract at the time of delivery;

(2) For cost-type or undefinitized line, subline, or exhibit line items, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery; and

(3) For items produced under a time-and-materials contract, the Contractor's estimated fully burdened unit cost to the Government at the time of delivery.

Issuing agency means an organization responsible for assigning a globally unique identifier to an enterprise (e.g., Dun & Bradstreet's Data Universal Numbering System (DUNS) Number, GS1 Company Prefix, Allied Committee 135 NATO Commercial and Government Entity (NCAGE)/Commercial and Government Entity (CAGE) Code, or the Coded Representation of the North American Telecommunications Industry Manufacturers, Suppliers, and Related Service Companies (ATIS-0322000) Number), European Health Industry Business Communication Council (EHIBCC) and Health Industry Business Communication Council (HIBCC)), as indicated in the Register of Issuing Agency Codes for ISO/IEC 15459, located at <http://www.nen.nl/web/Normen-ontwikkelen/ISOIEC-15459-Issuing-Agency-Codes.htm>.

Issuing agency code means a code that designates the registration (or controlling) authority for the enterprise identifier.

Item means a single hardware article or a single unit formed by a grouping of subassemblies, components, or constituent parts.

Lot or batch number means an identifying number assigned by the enterprise to a designated group of items, usually referred to as either a lot or a batch, all of which were manufactured under identical conditions.

Machine-readable means an automatic identification technology media, such as bar codes, contact memory buttons, radio frequency identification, or optical memory cards.

Original part number means a combination of numbers or letters assigned by the enterprise at item creation to a class of items with the same form, fit, function, and interface.

Parent item means the item assembly, intermediate component, or subassembly that has an embedded item with a unique item identifier or DoD recognized unique identification equivalent.

Serial number within the enterprise identifier means a combination of numbers, letters, or symbols assigned by the enterprise to an item that provides for the differentiation of that item from any other like and unlike item and is never used again within the enterprise.

Serial number within the part, lot, or batch number means a combination of numbers or letters assigned by the enterprise to an item that provides for the differentiation of that item from any other like item within a part, lot, or batch number assignment.

Serialization within the enterprise identifier means each item produced is assigned a serial number that is unique among all the tangible items produced by the enterprise and is never used again. The enterprise is responsible for ensuring unique serialization within the enterprise identifier.

Serialization within the part, lot, or batch number means each item of a particular part, lot, or batch number is assigned a unique serial number within that part, lot, or batch number assignment. The enterprise is responsible for ensuring unique serialization within the part, lot, or batch number within the enterprise identifier.

Unique item identifier means a set of data elements marked on items that is globally unique and unambiguous. The term includes a concatenated unique item identifier or a DoD recognized unique identification equivalent.

Unique item identifier type means a designator to indicate which method of uniquely identifying a part has been used. The current list of accepted unique item identifier types is maintained at http://www.acq.osd.mil/dpap/pdi/uid/uii_types.html.

(c) Unique item identifier.

(ii) The encoded data elements of the unique item identifier conform to the transfer structure, syntax, and coding of messages and data formats specified for Format Indicators 05, 06, and 12 in ISO/IEC International Standard 15434, Information Technology--Transfer Syntax for High Capacity Automatic Data Capture Media.

(4) Unique item identifier.
