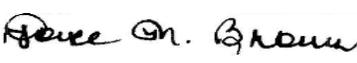

STATEMENT OF WORK

SOW for Add On Armor (AOA) Refurbishment Program
Performance Work Statement
August 22, 2012

1. General Information:

This contract is to augment Red River Army Depot (RRAD) maintenance capabilities. Contractor will be responsible for the COMPLETE REFURBISHMENT of the Add On Armor (AOA) Kits listed on the Scope of Work (SOW). Contractor will be responsible to provide a secured facility (to include a perimeter fence that meets or exceeds the standards for perimeter fencing as outlined in Army Tactics, Techniques and Procedures (ATTP) 3-39.32) for labor, tooling, transportation and all required parts as a requirement to bid on this contract. Contractor will be returning all assets worked under this SOW to Condition Code "A". Contractor's facility must be within 100 miles from the depot. All hired subcontractors must be within this 100 miles as well. Subcontractors must be approved by RRAD before the contractor will be authorized to use them. All parts installed by the contractor must meet or exceed U.S. Army specifications.

3. Technical Data:

Contractor is responsible for having all referenced Technical Manuals, Technical Bulletins, Mil-Specifications, Federal Standards and any other referenced technical data on hand at the contractor facility to ensure compliance with the SOW and Tech Data.

Any variation from the Mil-Specs or Products referenced in this SOW must be approved in writing by the Contracting Officer prior to it being used by the contractor. Any deviation from this SOW without consent is un-authorized.

4. Definitions:

- A. Condition Code "A": Serviceable/Issuable without qualifications, new, used, repaired or reconditioned material that is serviceable and issuable without limitations or restrictions.
- B. Repair: Restoring a component to its original performance condition, replacing parts if necessary.
- C. Original Equipment Manufacturer (OEM): The company that originally manufactured, fabricated, or supplied the component or part. OEM may include items manufactured by a subcontractor for an original equipment manufacturer, provided that the name or trademark of the OEM is shown on the item, label, or container.
- D. Serviceable Part: Any part that is capable of meeting or exceeding the minimum OEM standards for performing the function for which it was originally designed.

- E. Unserviceable Part: Any part that no longer meets minimum OEM standards.
- F. Mandatory Replacement Part: Parts / components that shall be replaced on each kit that is repaired.
- G. Rust Removal: Is physically removing rust from the surface, taking it to bare metal, then priming and painting the areas as required per the paint TMs and TBs.
- H. Rust Proofing: Is applying a chemical compound to the metal to prevent rusting.
- I. Government Furnished Material (GFM): Property in the possession of, or directly acquired by, the Government and subsequently furnished to the contractor for performance of a contract.

5. Contractor Requirements:

RRAD will furnish the contractor all AOA Kit pieces and components for all above mentioned kits as Government Furnished Material (GFM). Contractor will be responsible for the transportation by semi-truck and trailer of all GFM and completed kits to and from RRAD and the contractor facility. Cabs received with AOA applied will require contractor to remove AOA from these cabs to use as reclaim for kitting. There will be a joint inventory between RRAD and the contractor of all GFM upon receipt of award. This inventory will be accomplished at the contractor facility, this will be accomplished by manually counting all assets. At conclusion of inventory, both contractor and government representative will sign the inventory sheet and a copy will be retained on file by the COR. Contractor will have 30 days to inventory all GFM, at the end of 30 days, contractor will provide RRAD with a list of items to include quantities by NSN and Part Number they received from RRAD. Contractor will then have 15 days to order all other parts needed to complete the kits. At the end of 15 days, contractor will provide to RRAD a list of all parts on order to include quantities and an estimated delivery date from their vendor. Once the AOA is removed, it will be determined if it is salvageable by the contractor, IAW applicable technical requirements listed in this SOW. If not salvageable, it will be ordered and replaced in each kit as necessary. Contractor will be responsible for scrapping / salvaging all unserviceable components to include but not limited to the cabs and armor plating. All items determined to be used as reclaim will be cleaned, blasted, inspected, primed and painted prior to re-kitting into the AOA kits IAW instructions in this SOW and applicable technical requirements.

Delivery will be 1 kit per day with a 7 day turn around time. This will be after parts have been ordered and arrived. Estimated delivery requirement will be 20 kits per month, this will be based on RRAD production schedules and demands. Also, this delivery requirement will be subject to change based on customer requirements and availability of parts.

Contractor will be responsible for building containers to hold the AOA kits, IAW applicable technical requirements referenced in this SOW, for shipping to RRAD and returning to Army supply system. The containers will hold all pieces of the AOA kits and will include packing lists of items contained in the containers, and a set of installation instructions. No incomplete kits will be accepted and no incomplete kits will be returned to RRAD.

Note: On the M915 and PLS, there are two containers used per kit;

Dimensions for the containers will be:

M915 - 99"L x 67"W x 20"H

PLS - 99"L x 67"W x 20"H

Once all components of kit are ready for packing into containers, they will be inventoried and packed by contractor. RRAD will do random inspections to inspect quality and accountability of components to the kits. RRAD will inspect kits at the contractor facility prior to contractor sealing them. RRAD will notify contractor of inspection request prior to sealing container to allow RRAD inspection of kit. All kits will be returned via contractor semi-tractor and trailer to RRAD and will be marked IAW applicable technical requirements referenced in this SOW. One packing list will be attached to the exterior of each crate with staple gun and there will be a packing list inside each crate. The kits are extremely heavy and care must be taken to ensure the container is strong enough and reinforced to hold all components without failure.

6. Mandatory Replacement Parts:

IAW all applicable technical requirements listed in this SOW, all ballistic glass panels, seals, mounting hardware, latch mechanisms, hinges and fasteners require 100% replacement with new parts. Armor components found to be non-serviceable by the COR shall be discarded. Serviceable armor shall be retained.

7. General Inspection Criteria:

IAW all applicable technical requirements listed in this SOW, armor components with stage three or stage four corrosion shall be discarded. These will be mandatory replacement parts for the reset armor kit. Components with stage one or stage two corrosion will be retained for refurbishment. Armor components with non-standard user modifications shall be discarded.

IAW all applicable technical requirements listed in this SOW, examine areas around bolt holes for cracks or elongation of the holes. Cracks that are 1 inch or longer, or two consecutive elongated holes are cause to replace the armored panel. Look for signs that the armor has been deformed or damaged, including:

- a. Armor that is dented or bent out of shape, this shall be discarded.
- b. Bent door frames and door support panels which will not allow the doors to close properly, shall be discarded.
- c. Door handles that are not operational shall be replaced and doors shall be made functional.
- d. Windshield wiper systems shall be functional.

IAW all applicable technical requirements listed in this SOW, armor that passes inspection shall be cleaned and prepared for painting. Paint, corrosion and rust removal will be to the degree that allows for inspection and proper sanding and repainting.

8. Painting

All components of AOA will be primed and painted IAW applicable technical requirements listed in this SOW. All retained armor shall be painted tan unless otherwise directed by TACOM in writing one calendar month prior to the vehicle arrival at the Center of Excellence Location. Paint will be to condition code "A" standards, no runs, drips, fisheyes, streaks or flaking of paint will be allowed. Glass used IAW applicable technical requirements listed in this SOW, will be free of paint and any tape residue prior to packing into kits. No overspray is allowed on glass. If there is any rubber components present in these kits, overspray is not allowed on any rubber. If overspray is found, it is the contractors responsibility to bear the costs of repairing these items in full.

All corroded area will be treated, after cleaning and corrosion removal, with a commercially available, RRAD approved, rust inhibitor. The commercial brand "One Step" or "Silver Max", as listed below is approved for use. Use of any other rust inhibitor must be approved by the RRAD Quality Inspector, prior to use. All areas treated for rust and corrosion will be primed over after the rust inhibitor has been applied.

Rust Inhibitors:

1. One Step Aerosol – PN 3509 Talsol-Bondo / Marhyde
2. One Step Liquid – PN 3512 Talsol-Bondo / Marhyde
3. Silvermax / Rustbullet FPS Enterprises in Jean, Nevada

All priming and painting will be performed IAW applicable technical requirements set forth in this SOW. Regardless of the number of layers of topcoat, the total dry film thickness (from substrate to outer layer) shall not exceed 13 mils.

9. Workmanship

All workmanship will be consistent with condition code "A" standards and IAW all applicable technical requirements set forth in this SOW. Failure to comply with any of the specified requirements listed herein shall be reason for rejection by the RRAD representative. The contractor shall, at no cost to RRAD, submit for approval to the COR an approach for correction of all deficiencies. Upon approval of a documented approach, the contractor shall correct the deficiencies and repeat the verification until compliance with acceptance procedures requirements is demonstrated. Deficiencies will be corrected at no additional cost to the Government. Turn around time for correcting deficiencies will be 5 working days.

10. Miscellaneous Provisions

The contractor shall provide weekly progress reports summarizing the progress and status of the program to the COR. The report will include all parts provided to the contractor by part number and/or NSN, and a timeline for their completion and return to the depot. Any difficulties encountered will be logged and provided to the COR.

Contractor will use DD Form 250 dated August 2000 as their method of providing proof to the COR that the kitted asset was accepted by RRAD. The contractor will either deliver the DD 250's by hand or via mail to the COR prior to submitting their invoice into WAWF. All DD 250's will be completely filled out and typed, not hand written. Contractors will ensure all paperwork is

delivered to the COR in a timely manner prior to invoicing in WAWF. Contractors will give the original DD250 to the COR for the official file. Contractors will generate DD 250's at their facility.

Contractor is responsible for picking up and delivering all assets to and from RRAD. Pick up times will be Monday through Thursday, 0700-1500. Contractor will also maintain insurance on all their vehicles moving assets to and from the depot, as well as insurance on their maintenance facility to protect all government property.

The Government is requiring the contractor to have quality assurance procedures in place to ensure that the requirements of this SOW and the referenced documents are met. Contractor is required to have in process check sheets on hand to ensure all processes are done correctly and accountability is present to ensure all AOA Kits are rebuilt IAW the SOW and the quality level is to RRAD standards. Procedures are to be written, on hand at the work site, and are to be provided to the Government if requested by the Contracting Officer or his representative.

The Government will periodically make in-process reviews and inspections to ensure compliance with this SOW and referenced documents. These inspections may be unannounced, however, prior to entering the contractor work areas, the RRAD representatives will meet in the contractors main office area to ensure there is no disruption of work and will be at no cost to the Government. Inspection may be accomplished at any work location. Authorized RRAD representatives shall be permitted to observe the work/task accomplishment or to conduct inspections at all reasonable hours. (c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed 3 years.

52.222-4029 WAGE RATES (Jul 2005)

The attached schedule of Wage Rates No. WD-05-2235-12 was authorized by the Secretary of Labor to be the prevailing wage rates for construction and maintenance contracts at Red River Army Depot, Bowie County, Texarkana, Texas. 52.223-6 DRUG-FREE WORKPLACE (MAY 2001)

(a) Definitions. As used in this clause --

"Controlled substance" means a controlled substance in schedules I through V of section 202 of the Controlled Substances Act (21 U.S.C. 812) and as further defined in regulation at 21 CFR 1308.11 - 1308.15.

"Conviction" means a finding of guilt (including a plea of nolo contendere) or imposition of sentence, or both, by any judicial body charged with the responsibility to determine violations of the Federal or State criminal drug statutes.

"Criminal drug statute" means a Federal or non-Federal criminal statute involving the manufacture, distribution, dispensing, possession, or use of any controlled substance.

"Drug-free workplace" means the site(s) for the performance of work done by the Contractor in connection with a specific contract at which employees of the Contractor are prohibited from engaging in the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance.

"Employee" means an employee of a Contractor directly engaged in the performance of work under a Government contract. "Directly engaged" is defined to include all direct cost employees and any other Contractor employee who has other than a minimal impact or involvement in contract performance.

"Individual" means an offeror/contractor that has no more than one employee including the offeror/contractor.

(b) The Contractor, if other than an individual, shall-- within 30 days after award (unless a longer period is agreed to in writing for contracts of 30 days or more performance duration), or as soon as possible for contracts of less than 30 days performance duration--

(1) Publish a statement notifying its employees that the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance is prohibited in the Contractor's workplace and specifying the actions that will be taken against employees for violations of such prohibition;

(2) Establish an ongoing drug-free awareness program to inform such employees about--

(i) The dangers of drug abuse in the workplace;

(ii) The Contractor's policy of maintaining a drug-free workplace;

(iii) Any available drug counseling, rehabilitation, and employee assistance programs; and

(iv) The penalties that may be imposed upon employees for drug abuse violations occurring in the workplace;

(3) Provide all employees engaged in performance of the contract with a copy of the statement required by subparagraph (b)(1) of this clause;

(4) Notify such employees in writing in the statement required by subparagraph (b)(1) of this clause that, as a condition of continued employment on this contract, the employee will--

(i) Abide by the terms of the statement; and

(ii) Notify the employer in writing of the employee's conviction under a criminal drug statute for a violation occurring in the workplace no later than 5 days after such conviction.

(5) Notify the Contracting Officer in writing within 10 days after receiving notice under subdivision (b)(4)(ii) of this clause, from an employee or otherwise receiving actual notice of such conviction. The notice shall include the position title of the employee;

(6) Within 30 days after receiving notice under subdivision (b)(4)(ii) of this clause of a conviction, take one of the following actions with respect to any employee who is convicted of a drug abuse violation occurring in the workplace:

(i) Taking appropriate personnel action against such employee, up to and including termination; or

(ii) Require such employee to satisfactorily participate in a drug abuse assistance or rehabilitation program approved for such purposes by a Federal, State, or local health, law enforcement, or other appropriate agency; and

(7) Make a good faith effort to maintain a drug-free workplace through implementation of subparagraphs (b)(1) through (b)(6) of this clause.

(c) The Contractor, if an individual, agrees by award of the contract or acceptance of a purchase order, not to engage in the unlawful manufacture, distribution, dispensing, possession, or use of a controlled substance while performing this contract.

(d) In addition to other remedies available to the Government, the Contractor's failure to comply with the requirements of paragraph (b) or (c) of this clause may, pursuant to FAR 23.506, render the Contractor subject to suspension of contract payments, termination of the contract for default, and suspension or debarment.

52.223-11 OZONE-DEPLETING SUBSTANCES (MAY 2001)

(a) Definition. Ozone-depleting substance, as used in this clause, means any substance the Environmental Protection Agency designates in 40 CFR part 82 as--

(1) Class I, including, but not limited to, chlorofluorocarbons, halons, carbon tetrachloride, and methyl chloroform;
or

(2) Class II, including, but not limited to, hydrochlorofluorocarbons.

(b) The Contractor shall label products which contain or are manufactured with ozone-depleting substances in the manner and to the extent required by 42 U.S.C. 7671j (b), (c), and (d) and 40 CFR Part 82, Subpart E, as follows:

“WARNING: Contains (or manufactured with, if applicable), a substance(s) which harm(s) public health and environment by destroying ozone in the upper atmosphere.”-----

The Contractor shall insert the name of the substance(s).

52.233-3 PROTEST AFTER AWARD (AUG. 1996)

(a) Upon receipt of a notice of protest (as defined in FAR 33.101) or a determination that a protest is likely (see FAR 33.102(d)), the Contracting Officer may, by written order to the Contractor, direct the Contractor to stop performance of the work called for by this contract. The order shall be specifically identified as a stop-work order issued under this clause. Upon receipt of the order, the Contractor shall immediately comply with its terms and take all reasonable steps to minimize the incurrence of costs allocable to the work covered by the order during the period of work stoppage. Upon receipt of the final decision in the protest, the Contracting Officer shall either--

(1) Cancel the stop-work order; or

(2) Terminate the work covered by the order as provided in the Default, or the Termination for Convenience of the Government, clause of this contract.

(b) If a stop-work order issued under this clause is canceled either before or after a final decision in the protest, the Contractor shall resume work. The Contracting Officer shall make an equitable adjustment in the delivery schedule or contract price, or both, and the contract shall be modified, in writing, accordingly, if--

(1) The stop-work order results in an increase in the time required for, or in the Contractor's cost properly allocable to, the performance of any part of this contract; and

(2) The Contractor asserts its right to an adjustment within 30 days after the end of the period of work stoppage; provided, that if the Contracting Officer decides the facts justify the action, the Contracting Officer may receive and act upon a proposal at any time before final payment under this contract.

(c) If a stop-work order is not canceled and the work covered by the order is terminated for the convenience of the Government, the Contracting Officer shall allow reasonable costs resulting from the stop-work order in arriving at the termination settlement.

(d) If a stop-work order is not canceled and the work covered by the order is terminated for default, the Contracting Officer shall allow, by equitable adjustment or otherwise, reasonable costs resulting from the stop-work order.

(e) The Government's rights to terminate this contract at any time are not affected by action taken under this clause.

(f) If, as the result of the Contractor's intentional or negligent misstatement, misrepresentation, or miscertification, a protest related to this contract is sustained, and the Government pays costs, as provided in FAR 33.102(b)(2) or 33.104(h)(1), the Government may require the Contractor to reimburse the Government the amount of such costs. In addition to any other remedy available, and pursuant to the requirements of Subpart 32.6, the Government may collect this debt by offsetting the amount against any payment due the Contractor under any contract between the Contractor and the Government.

52.236-4031 SECURITY REGULATIONS (Apr 1994)

(a) All contractors, subcontractors, and their employees are responsible for complying with the following regulations:

(1) Items forbidden on the depot include "strike anywhere" matches, alcoholic beverages, narcotics, photographic equipment, unauthorized tools, firearms, explosives and illegal knives (stilettoes, switchblades, hook blades, and blades over three inches in length).

(2) Personnel will not retain passes and badges upon job completion or termination, enter depot in an intoxicated condition, fight, gamble, picket, or create a disturbance. Failure to return badges will cost your firm \$50.00 per badge.

(3) Contractor will ensure that all contractor employees comply with all applicable fire, safety, and security requirements and adhere to all applicable state and federal labor laws and regulations.

(b) General Instructions:

(1) All depot traffic regulations will be observed.

(2) Predetermined work routes will be followed with no deviation.

(3) All personal vehicles and containers are subject to search and confiscation of unauthorized items while on the depot (with or without presence of owner).

(4) Notorious misconduct off the depot may be sufficient grounds for denying entrance to the depot.

(5) POV'S must have a minimum insurance coverage and state inspection sticker, in accordance with Texas State Laws.

(6) All personnel will adhere to all depot fire, safety, security, and other applicable regulations.

52.236-4032 SAFETY AND OCCUPATIONAL HEALTH REQUIREMENTS (Jan 2010)

(a) The contractor shall furnish all personnel and material necessary for the prevention of accidents, injury or damage to employees or equipment while operating on a Federal reservation. Also includes personnel and equipment necessary for the prevention of accidental damage to Government property, Federal employees or other U.S. Government contractor personnel.

(b) The contractor and his employees to include subcontractors and their employees, will comply with all Federal, state and local laws pertaining to traffic safety and safety of public rights of way. In addition, the contractor or his authorized agent will comply with the Occupational Safety and Health Act Parts 1910 and 1926, the U.S. Army Engineer Manual 385-1-1, Army Regulations, Red River Regulations 385-1, and the Uniform Code of Traffic Control Devices.

(c) Each contractor shall have a written contractors safety program and policy. In cases where the subcontractor has a written regulation for its employees, a copy of that regulation will be forwarded to the contractor for forwarding to the Contracting Officer, prior to commencement of work.

(d) Subcontractors and Employees. Each subcontractor shall be considered a contractor employee for purposes of this section.

(e) Warning signs, barricades, and detours. The contractor shall furnish and erect adequate warning signs, flashing lights, and barricades to properly control traffic movements around or through the construction site. The contractor shall provide and maintain any detours or crossovers necessary for the safety and convenience of traffic.

(f) Contractor and Employee Vehicles. Contractor vehicles must meet with current state safety regulations and an appropriate sticker affixed in the lower left corner of the windshield. Vehicles not meeting the state safety codes will not be allowed on RRAD. Those which have a safety inspection expire while on RRAD will be removed and properly recertified NLT 15 days prior to the expiration date. Vehicles found to be out of inspection date will be ordered off of the depot and the contractor decal removed. Vehicles found by RRAD Safety personnel to be unsafe for RRAD operations will be brought to the attention of the contractor who will either repair the vehicle or remove it.

(g) Contractors are responsible for their employees' conduct and their vehicles. Employees with unsafe vehicles will be required to remove them from RRAD until they can be repaired.

(h) Accidents, other than minor first aid injuries, should be reported to the COR and/or Contract Administrator who will inform Safety as appropriate. These are reportable on a Department of Army Form 285 when they occur on U.S. Federal property.

(i) The Contracting Officer will notify the contractor in writing of any observed non-compliance with the foregoing provisions. The contractor shall, after receipt of such notice, immediately take corrective action. The Safety Manager may make direct contact with a contractor or his authorized representative for conditions of imminent danger to life or U.S. Government property. In such cases, the Contracting Officer will be immediately notified. In cases which have the potential for embarrassment to the U.S. Government, or Red River Army Depot, the Contracting Officer will notify the contractor verbally to be followed up by a written report of the situation and the action to be taken to correct it. If the contractor fails or refuses to promptly take corrective action, the Contracting Officer will issue an order stopping all or part of the work until satisfactory corrective action has been taken. No part of the time lost due to such stop orders will be made the subject of a claim for extension of time or for excess costs or damages by the contractor unless it was later determined that the contractor was in compliance.

If you have complaints about this procurement, it is preferable that you first attempt to resolve those concerns with the responsible contracting officer. However, you can also protest to Headquarters, AMC. The HQAMC-Level Protest Program is intended to encourage interested parties to seek resolution of their concerns within AMC as an Alternative Dispute Resolution forum, rather than filing a protest with the Government Accountability Office or other external forum. Contract award or performance is suspended during the protest to the same extent, and within the same time periods, as if filed at the GAO. The AMC protest decision goal is to resolve protests within 20 working days from filing. To be timely, protests must be filed within the periods specified in FAR 33.103. If you want to file a protest under the HQAMC-Level Protest Program, the protest must request resolution under that program and be sent to the address below. All other agency-level protests should be sent to the contracting officer for resolution.
